Reports

- 1. Treasurer Report

- Brock made a motion to approve the Star Insurance bill for \$1,494.00. Kamm seconded the motion. All voted in favor. Motion passed.
- BPP Travco Plumbing Bill
 - Brock made a motion to approve the Travco Plumbing bill for \$834.03. Kamm seconded the motion. All voted in favor. Motion passed.
- First Midstate (bond)
 - The board discussed issuing a bond for \$210,000.
 - A public hearing will need to be conducted in November with a notice in a local paper seven days prior. A bond ordinance meeting will need to be held in December.
 - Possible uses of the money include installing bathrooms at Brighton Park, repairing bathrooms at Black Partridge Park, replacing old swingsets at Schupp Park, and replacing the gator.
 - Love endorsed the \$210,000 option to keep taxes the same. Brock and Kamm agreed. A consensus was reached to move forward with the \$210,000 option.
