	For committee reports, Chad Kamm with Midwest Building Systems and Andrew Kamm with Catalyst Construction spoke on the general cost of a Park District building and what the process of building may look like. Brock spoke on pickleball courts and forming a committee for them. She stated that she has started researching this project as the Village agreed that they will help with funding on two pickleball courts. Driskell spoke about the new Wednesday class at the Park District office focusing on pre-k aged children.

Informational Items

Budget Ordinance and Appropriation of Funds	Treasurer Eisele gave some information regarding the budget and the commissioners reviewed the presented budget and budget ordinance. Ways to save money at the pool were discussed, including potentially closing the concession stand. Garber spoke about setting the budget hearing for the same date as September's regular meeting.
Frisbee Golf at Black Partridge Park	Garber stated that she will be researching frisbee golf at Black Partridge Park because the Village confirmed they would help with funding for that project, also.
Movie at the Park	The commissioners decided the movie in the park should be met about at the beginning of 2024 in hopes of getting one on the calendar for next year.
Vacation Request	Garber put in a request for vacation for the last week of September, and the commissioners approved that time off.
Etcheson Spa and Pool Bill	A bill for the pool was presented to the board for a fix the pool needed during the season.
Night Swim at the Pool	Garber stated that Jamie, pool manager, brought the idea to her about offering a night swim for next season. They were going to look into both options of having or not having lifeguards for night swim before any decisions are made.
