Treasurer's Report

Treasurer's Report	Treasurer Rebecca Eisele gave the Treasurer's Report. The commissioners reviewed the report. During the treasurer's report, the amount of money lost by the pool was presented to the board. It was expected that the pool would lose around \$20,000, but the pool ended up losing close to \$50,000.00. Wages and repairs were what cost the most money for this pool season. The board discussed that the next step that needed to be taken was that the full numbers needed to be researched so that the public could be made aware of the situation, and a decision about the pool's future could be made.

New Security Cameras	Garber stated that she will be working on getting new cameras ordered, as the ones at the parks currently are outdated. She plans to communicate with the Park Foundation in hopes they would help fund the new cameras.
